Last month's meeting hosted by John Cole at the Lear plant on Alpine. This plant makes the seat tracks for a number of GM cars. At one time, this plant made all of the interiors for GM cars, including our Corvairs. There were 13 WMCC members in attendance with seven Corvairs. After a brief introduction about Lear and its history, John gave us a tour of the plant. The night foreman also gave an impromptu presentation part way through the tour. One interesting part was the wooden floor in the original part of the factory, which was built in the 1920's. There are wood blocks on top of a concrete floor. This floor was installed in the 1940's when production was converted for the war effort. We were told that the wood floors prevented build-up of static electricity when welding airplane fuselages. We also got to witness the assembly line at work in building some seat tracks. Thank you to John Cole for a fun and informative meeting.


