The only rule is that you must have personally built or assembled the kit yourself; no die-cast or pre-built models of any kind are eligible for entry. Those attending the meeting will be the judges and there will be ballots at the meeting.

We will also be holding elections for our board of directors at the November meeting. There are three positions that will need to be filled. The floor will be open for additional nominations before we hold the elections.

The date has been set for our annual Christmas party. It will be held on Saturday, December 8 at the home of Scott and Heather Olivier. More details will be published in the December newsletter.

The November board meeting will be on Tuesday, November 27 at AJ's, 1830 142nd Ave. in Dorr. Start time is 6:30 PM.
