There are no warranties, expressed or implied, on Chevrolet motor vehicles sold by Dealer except the following New Vehicle Warranty which Dealer, as Seller, and not as agent of the Manufacturer, gives to Purchaser on each new Chevrolet motor vehicle sold by Dealer:

"Dealer warrants each new Chevrolet motor vehicle and chassis, including all equipment or accessories thereon (except tires), sold by Dealer to be free from defects in material and workmanship under normal use and service, Dealer's obligation under this warranty being limited to making good any part or parts thereof which shall, within ninety (90) days after delivery of such vehicle or chassis to the original purchaser or before such vehicle or chassis has been driven 4,000 miles, whichever event shall first occur, be returned to Dealer at Dealer's place of business and which Dealer's examination shall disclose to its satisfaction to have been thus defective; this warranty being expressly in lieu of all other warranties, expressed or implied, and all other obligations or liabilities on Dealer's part, and Dealer neither assumes nor authorizes any other person to assume for it any other liability in connection with such motor vehicles or chassis.

"This warranty shall not apply to any motor vehicle or chassis which shall have been repaired or altered outside of an authorized Chevrolet dealership in any way so as in the judgment of Dealer to affect adversely its performance and reliability, nor which has been subject to misuse, negligence or accident."

3. OWNER RESPONSIBILITY—Proper maintenance and care of your Chevrolet will help you achieve lower overall operating costs. 4. TOURING OR CHANGE OF RESIDENCE—When touring or in the event you move prior to the expiration of the warranty period, any authorized Chevrolet Dealer in the U.S. or Canada will honor this policy.

#### OWNER SERVICE POLICY

The form on this page is your identification and introduction to any Chevrolet dealer in the United States and Canada. Be certain this is completely and properly filled out and signed by your selling Dealer or his authorized representative.

It is suggested that you keep this booklet in the glove compartment of your vehicle at all times. If you should find it necessary to visit another Chevrolet Dealer while out of town, this will furnish all of the necessary information in the event that warranty repairs are required.

#### Design Changes

The Manufacturer has reserved the right to make changes in design or add any improvements on motor vehicles and chassis at any time without incurring any obligation to install same on motor vehicles and chassis previously purchased.

#### **Tire Warranty**

Tires included as original equipment on Chevrolet vehicles are not included within the provisions of the new vehicle warranty. They are covered by the Tire Manufacturer's Warranty. Your Dealer will assist you when a tire adjustment is necessary.

#### **Battery Warranty**

The Delco Battery in your vehicle is covered by your Chevrolet Owner's Service Policy and is warranted for 90 days. Should it prove defective within this time, it shall be replaced at no cost. Should a defect become apparent after 90 days and within the prorated adjustment period set out in the Delco Remy Battery Warranty, your Dealer will assist you in effecting an adjustment.

#### Paint and Other Appearance Items

Imperfection in paint, trim or other appearance items is normally apparent and corrected during new vehicle pre-delivery conditioning. Damage due to usage is not covered by warranty. For your protection, you are urged to immediately call any imperfection to the attention of your selling Dealer, so that he may make any necessary correction.

#### THE OWNER SERVICE POLICY

1. DELIVERY—To help you secure maximum satisfaction with your new Chevrolet, it has been inspected and conditioned according to Chevrolet recommended pre-delivery inspection schedule.

2. VERIFICATION VOUCHER – Your Service Policy implements the New Vehicle Warranty and together they provide for the furnishing and installation of warranty parts within the warranty period without charge, by any authorized Chevrolet Dealer in the U. S. or Canada. A Verification Voucher included in this Chevrolet Owner Protection Policy Booklet must be surrendered to such Dealer performing any warranty service on your vehicle.
