**THIS OWNER PROTECTION PLAN BOOKLET** provides you with guides to be followed in obtaining service for the new Chevrolet you have just purchased.

This Booklet identifies you as the owner of the Chevrolet described therein. It will serve as a means of obtaining service for your Chevrolet from any authorized Chevrolet dealer in the United States or Canada. You should, therefore, keep this Booklet in the glove compartment of your car at all times.

This Booklet contains the Warranty given to you by the authorized Chevrolet dealer (sometimes referred to as the Dealer or selling dealer) who sold you your Chevrolet and the verification vouchers which you will use if warranty service becomes necessary. Such service, if possible, should be performed by the selling dealer because of his interest in your continued satisfaction with your new Chevrolet.

Certain "Guardian Maintenance" Service recommendations have been prepared and are set forth in this Booklet to assist you in the proper care and maintenance of your Chevrolet. If properly followed, these recommendations can be your best guide to many miles of motoring pleasure.

## NEW VEHICLE WARRANTY

Each new Chevrolet motor vehicle and chassis, including all equipment or accessories thereon manufactured or supplied by Chevrolet Motor Division of General Motors Corporation, sold by Dealer is hereby expressly warranted by Dealer, as Seller thereof and not as the agent of the Manufacturer, to be free from defects in material and workmanship under normal use and service.

Dealer's obligation under this Warranty is limited, however, to repairing or replacing at Dealer's option, any part of such motor vehicle or chassis which shall, within twelve (12) months after delivery of such vehicle or chassis to the original purchaser or before such vehicle or chassis has been driven twelve thousand (12,000) miles, whichever event shall first occur, be returned to Dealer at Dealer's place of business and which Dealer's examination shall disclose to its satisfaction to have been thus defective.

The repair or replacement of defective parts under this Warranty will be made by Dealer without charge for parts and, if made at Dealer's place of business, without charge for labor.

The provisions of this Warranty shall not apply (1) to tires or tubes, or (2) to normal maintenance services, including but not limited to, fuel system cleaning, wheel alignment and balancing, engine tune-up, and brake inspection or adjustment, nor to the replacement of filters when such replacements are made as part of any such normal maintenance service, or (3) to any motor vehicle or chassis which shall have been repaired or altered outside of an authorized Chevrolet dealership in any way so as in the judgment of Dealer to affect adversely its performance and reliability, or (4) to any motor vehicle or chassis which has been subject to misuse, negligence or accident.

**This warranty is expressly in lieu of all other warranties, expressed or implied, and all other obligations or liabilities on Dealer's part, and Dealer neither assumes nor authorizes any other person to assume for it any other liability in connection with such motor vehicles or chassis.**

## POLICY ON OWNER SERVICE

- 1. DELIVERY**—To help you secure maximum satisfaction with your new Chevrolet, it has been inspected and conditioned by the selling dealer according to the pre-delivery inspection schedule recommended by Chevrolet.
- 2. VERIFICATION VOUCHER**—When Warranty Service is performed on your vehicle by a Chevrolet Dealer, you will be required to sign and surrender to such Dealer one of the Verification Vouchers included in this Booklet. If such Verification Vouchers have been used or lost, notify such Dealer. Prior use or loss of Verification Vouchers does not in any way void or affect the New Vehicle Warranty. While services under the warranty may be furnished by any authorized Chevrolet Dealer, it is recommended that warranty services be performed by the Chevrolet Dealer issuing this booklet and from whom you purchased your vehicle, because of his continued and personal interest in you.
- 3. OWNER RESPONSIBILITY**—Proper maintenance and care of your Chevrolet will help you achieve lower overall operating costs. Also if your Chevrolet is regularly and properly maintained by competent technicians you will avoid conditions arising from neglect which are not covered by the warranty. In this connection maintenance services should be performed in accordance with the "Guardian Maintenance" service recommendations contained in this Booklet.
- 4. TOURING OR CHANGE OF RESIDENCE**—When touring or in the event you move prior to the expiration of the warranty period, any authorized Chevrolet Dealer in the U. S. or Canada will honor your warranty.

## POLICY ON OWNER SERVICE (Continued)

- 5. DESIGN CHANGES**—The Manufacturer has reserved the right to make changes in design or add any improvements on motor vehicles and chassis at any time without incurring any obligation to install same on motor vehicles and chassis previously purchased. Dealer reserves a similar right.
- 6. PAINT AND OTHER APPEARANCE ITEMS**—Imperfection in paint, trim or other appearance items is normally apparent and corrected during new vehicle pre-delivery conditioning. Damage due to usage is not covered by warranty. For your protection, you are urged to immediately call any imperfection to the attention of your selling Dealer, so that he may make any necessary correction.

### TIRE WARRANTY

Tires included as original equipment on Chevrolet vehicles are not included within the provisions of the New Vehicle Warranty. They are covered by the Tire Manufacturer's Guarantee. Your Dealer will assist you when a tire adjustment is necessary. In this connection your Owner Identification will provide you with the date of delivery of your vehicle.

### BATTERY WARRANTY

The Delco battery in your vehicle is covered against defects in material and workmanship under the terms of the New Vehicle Warranty for a period of twelve (12) months or twelve thousand (12,000) miles, whichever first occurs. The provisions which follow relating to battery service adjustments also apply to your Delco battery.

## DELCO BATTERY SERVICE ADJUSTMENTS

For the purposes of these adjustments the following terms shall have the following meanings:

**Adjusted Service Period**—The period commencing with the expiration of the warranty period and expiring twenty-four (24) months (in the case of the Corvair) and thirty-six (36) months (in the case of all other Chevrolet passenger cars) from the date of delivery of the vehicle to the original purchaser if in normal passenger car use. (For other types of passenger car use, such as taxicabs and police cars, see your Chevrolet or Delco battery dealer to determine the Adjusted Service Period applicable to the Delco battery in your particular vehicle.)

**Months of Service**—The total months covered by both the Warranty and Adjusted Service Periods. The "months of service" commence to run on the date of delivery of the new vehicle to the original purchaser.

**Undelivered Months of Service**—The difference between the "months of service" and the months of actual service received.

**Owner's Cost Per Month**—The per month cost of the replaced battery to the owner determined by dividing the "months of service" into its current Delco battery manufacturer's suggested list price (or fleet owner's current cost).

## DELCO BATTERY SERVICE ADJUSTMENTS (Continued)

Should the Delco battery in your vehicle prove defective under normal passenger car use within the Adjusted Service Period the defective battery can be exchanged for a new Delco battery of equal or greater capacity on an adjusted service (pro rata) basis at the place of business of an authorized Chevrolet dealer or Delco battery dealer. Credit toward the purchase of such new Delco battery will be equal to the "owner's cost per month" of the replaced battery multiplied by the number of "undelivered months of service".

Upon the expiration of the warranty, the Adjusted Service Period applies on a "months of service" basis only and mileage is not a factor. In no event is the date of installation of a replacement battery installed without charge pursuant to the warranty used as the beginning date for the months of service.

The provisions of this Delco Battery Service Adjustments shall not apply (A) to failure in service due to misuse, negligence or accident, including but not limited to improper installation, freezing, failure to have battery inspected regularly and filled with colorless, odorless drinking water when needed, use of electrolyte other than "battery grade" sulphuric acid solution of a specific gravity recommended by Delco-Remy Division of General Motors Corporation, or (B) to costs for recharging this battery or for the use of a rental battery.
